Please note that this form is valid for customers who wish to appeal 407 ETR's decision made in response to a notice of dispute.

APPEAL INSTRUCTIONS:

- Review and confirm eligibility to appeal, below.
- Complete a notice of appeal and deliver it to the Arbitrator by one of the methods described below.
- At the same time, submit an identical copy of your appeal (with supporting materials if applicable) together with the appeal fee, to 407 ETR by one of the methods shown at the bottom of this page.

APPEAL FEE:

To process your appeal a \$100.00 appeal fee (plus HST) must be paid to 407 ETR by credit card, certified cheque, cash, bank draft, or money order. If your appeal is successful, the appeal fee will be refunded to you by 407 ETR within 10 business days of receipt of the Dispute Arbitrator's decision.

APPLICABLE LAW:

The appeal process is governed by the Highway 407 Act and/or the Highway 407 East Act, as applicable. The Arbitrator will decide the appeal solely on the grounds set out therein. An electronic copy of each law can be found at http://www.e-laws.gov.on.ca
